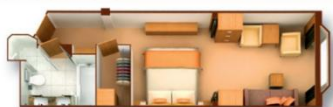

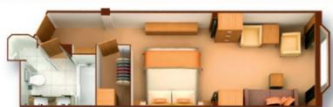

Fee includes:

Fees do not include:

- Shore excursions (at cost), food and drinks (at cost), onboard insurance (if applicable)
- Passport issuance/visa fees, travel insurance, other personal expenses
- Airfare, hotel accommodation, port transfers, optional excursions, all personal expenses such as laundry, telephone, fax, etc.
- Tourism Regulatory Authority stamp duty (0.15%)
- Other charges not listed here.

Remark:

1. Our company will charge customers a printing cost. The printing cost is calculated as 0.15% of the final total charge.
2. The price is calculated per adult (two adults per room) and is in Hong Kong dollars. Please contact us for pricing on single rooms, rooms shared by three or four people, or for children. A single room surcharge applies to single occupancy.
3. All charges on the cruise ship are settled in US dollars. Please note.
4. All sailings require a minimum of 190 passengers to proceed.
5. Terms and prices are subject to change without notice. Prices are subject to availability and are valid upon receipt of a deposit.
6. If the cruise line charges additional fuel surcharges or other taxes, passengers will need to pay the difference. The actual amount will be based on the date the cruise line's announcement is issued. This amount will be determined after confirmation and added to the final ticket price.
7. Customers must ensure that their travel documents are valid for at least 6 months (calculated from the return date, except for certain countries) and have sufficient blank pages for visa and entry purposes. Passengers must also hold a valid entry visa (if applicable). Our company and the cruise line are not responsible for any problems arising from passengers' personal documents.
8. When making a reservation, customers must verify that their name matches their travel document exactly. Otherwise, they will lose the original reservation price and discounts or be required to pay any change-related fees. The cruise company also has the right to refuse boarding to customers. The final decision rests with the cruise company, and customers may not object.
9. Tickets are non-transferable, non-refundable, and non-changeable under any circumstances.
10. From the date of boarding, each cabin must have at least one adult aged 18 or older to participate in this trip.
11. All cabin compartments, such as single beds, extra beds, or bunk beds, are arranged by the cruise line.
12. Seating arrangements for dinner on the cruise ship (in the main dining room) and the final arrangements and decisions of the cruise company.
13. If the cruise line is unable to dock or the entire itinerary is altered due to severe weather, sea conditions, or other unforeseen or unavoidable circumstances (such as war, political unrest, natural disasters, epidemics, typhoons, severe weather, rough seas, technical problems with the transport vehicle, temporary changes to schedules or timetables by the transport company, strikes, and industrial actions), the customer must agree to and accept the cruise line's arrangements. Neither the company nor the cruise line is required to provide any compensation.
14. Departure/arrival/stop times at ports during the voyage may be adjusted/changed/cancelled depending on sailing conditions, subject to the cruise company's final arrangements, which the customer agrees to and accepts. The cruise company has the final decision-making right and this will not be considered a violation of the trade description regulations; therefore, the customer waives the right to pursue or claim compensation from the cruise company or this company.
15. The company and the cruise line reserve the right to adjust all itinerary arrangements based on the cruise ship's arrival time at the port and local traffic conditions on the day of travel, without providing compensation, and participants shall not raise any objections.
16. If the itinerary is delayed due to customs clearance or immigration procedures at the port of call, resulting in additions, subtractions, or changes to the itinerary, neither our company nor the cruise company will provide any compensation, and guests shall not raise any objections.
17. Passengers are advised to purchase comprehensive travel insurance before departure.
18. Cruise lines may adjust their prices from time to time according to market demand. All prices are for reference only. The actual price will be subject to the official reply from the cruise line when you make a formal inquiry and confirm your booking.
19. All promotional offers and discounted room rates are limited and available on a first-come, first-served basis, while supplies last.
20. Customers must provide a copy of their valid travel document when registering.
21. If a child's travel document is attached to a parent's passport/return permit, the child may not travel alone unless accompanied by that guardian.
22. Pregnant women who are 24 weeks or more pregnant (calculated from the date of embarkation) are not allowed to board the cruise ship. Guests who are 20-23 weeks pregnant need to present a doctor's certificate. The maximum pregnancy period varies for some cruise lines and specific cruises. Please contact our company for details (subject to change by the cruise line).

The new legislative control of cannabidiol (CBD) will come into effect on February 1. CBD will be under the same strict control as other dangerous drugs under the Dangerous Drugs Ordinance (DDO) from that day. With the commencement of the new regulation, Hong Kong Customs will take vigorous enforcement action to fiercely combat the related drug trafficking activities.

Under the DDO, trafficking (including importing and exporting) and illicit manufacturing of CBD is liable to a maximum penalty of a fine of \$5 million and life imprisonment. Possession and consumption of CBD in contravention of the DDO will be subject to a maximum penalty of a fine of \$1 million and imprisonment of seven years.

From February 1 onwards, importation of products (including food or drinks) containing CBD into Hong Kong is prohibited unless the relevant provisions in the DDO are complied with.

Customs will step up enforcement action to intercept the import and transit movements of CBD products in various channels. At the same time, Customs will continue to apply risk assessment strategy to select passengers, cargoes and postal packets for clearance to combat transnational drug trafficking activities.

Customs reminds members of the public not to bring any cannabis products or products containing CBD into Hong Kong. To avoid breaching the law inadvertently, they should also refrain from buying any CBD products, and pay attention to whether the products' packaging and labels contain wordings of CBD or tetrahydrocannabinol (THC) when making any purchase. When in doubt, members of the public should not take the risk of buying these products or bringing them back to Hong Kong.
